The Series A Preferred Stock has no expiration date.
- The shares underlying this option vest in sixteen equal quarterly installments following March 1, 2023, subject to the Reporting Person's continued service on each such vesting date.
- The shares underlying this option vest in sixteen equal quarterly installments following February 1, 2024, subject to the Reporting Person's continued service on each such vesting date.
- The shares underlying this option vest in sixteen equal quarterly installments following February 1, 2025, subject to the Reporting Person's continued service on each such vesting date.
